
Dr. Ahmed has been in the teaching and research profession for over 20 years. He has taught math, physics, engineering,



THE HISTORICAL USE OF WESTPHALIAN SOVEREIGNTY TO DENY BLACK CITIZENSHIP

#### DR. SHERICE JANAYE NELSON

#### **ABSTRACT**

The work explores the intersections of the social contract, the racial contract, sovereignty, and Black citizenship. The form or process of civil government, known as polity, is constructed through the social contract which is described as a moral partnership. This partnership is contrived by citizens relinquishing their rights in exchange for protection by the state. Such a partnership is bound to the confines of territorial borders which were permanently established by the Treaty of Westphalia in 1648. Westphalian sovereignty grants the state the ability to define citizenship, which is inherently problematic for Blacks in Eurocentric territories because they are not seen as moral. This lack of morality places a strain on their ability to participate in polity as they are deemed unworthy. This unworthiness results in otherness, which is the lack of belonging, making Blacks ineligible for full citizenship.

Charles Mills contends that the social contract does not exist for Blacks. This is due to a racial hierarchy which had established Whiteness as supreme in the United States and globally. Consequently, Blacks must consistently fight to be seen as citizens in their territorial spaces, and must fight to enjoy all the protections of citizenship especially in America. This article furthers the argument of Mills through a historical examination of the political theoretical foundation of the United States. It will demonstrate that the United States desire to be seen as a legitimate sovereign nation after the American Revolution, required compliance with the tenets of Westphalian sovereignty. Therefore, slavery is constricted inside of territorial boundaries while simultaneously used as a barometer for citizenship in the formation of the state through the United States Constitution. Consequently, this paper will argue that Blacks fight for full citizenship is centered around Black unworthiness rooted in the nation's founding. Such unworthiness is justified by ascribing Blacks as amoral making it impossible for them to belong to a country built on Christian values.





#### THE THREAT OF GLOBAL DISEASE IN SEEKING MORE RACIALLY EQUITABLE TRADE

#### **ABSTRACT**

A major feature of the American economy focuses on international trade involving exports to foreign countries around the world. Yet the participation of small and medium size enterprises representative of diverse racial and ethnic communities within the US has been dismal, especially in the new era of highly contagious viruses and diseases. Despite recent executive orders of the Biden Administration to make diversity in this area a priority, there has not been a serious effort to understand the nature of the barriers to the creation of successful participation by small and medium size enterprises from diverse communities given the new world health environment. This presentation will explore the nature of the existing world situation and way global economies have to attempted to mitigate racial and ethnic inequalities in this new environment of global exporting. # ETHICS AND HEALTHCARE ADMINISTRATORS' DECISION-MAKING: THE SYMPHONOLOGICAL BIOETHICAL FRAMEWORK

#### **ABSTRACT**

Healthcare administrators are challenged by ethical dilemmas and reconciling business, clinical, and operational demands within the bounds of ethical practice. Grounded theory was used to develop an actionable model promoting ethics in healthcare administrators' decision-making processes. In this study, qualitative data on healthcare administrators' ethical dilemmas were collected from scholarly peer-reviewed manuscripts, reports, and public records. NVivo 10 was used to analyze data, identify themes, build a new substantive theory, and suggest a conceptual model. The symphonological bioethical framework provides context to facilitate healthcare administrators' decision-making processes. This study contributes to the limited research on healthcare administrators' ethical decision-making

#### **ABSTRACT**

The purpose of this presentation is to discuss the advances in self-reporting of Driving While Intoxicated (DWI) and Driving Under the Influence (DUI) since research that studied exploring the impact of punishment on driving while intoxicated (DWI) and driving under the influence (DUI) defendants (Scott, 2015). In this presentation, the researcher will discuss research prior to 2015, research from 2015, and research after 2015 related to DWI/DUI self-reporting of DWI/DUI behaviors and punishment as well as self-reporting related to alcohol cravings and self- reporting of access to drinking settings. Social justice concerns, implications and future research will be discussed.

# DR. PERRY LYLE, COLUMBIA COLLEGE & DR. ASHRAF ESMAIL, DILLARD UNIVERSITY

#### **ABSTRACT**

The focus of this presentation is on bioterrorism and understanding global threats. A disclaimer is warranted as we should know that the subject of bioterrorism has to be approached with an understanding of man-made and natural occurring events to put the lecture into perspective. One cannot always distinguish where one begins and the other ends. Nations, foreign actors, and terrorists have always shrouded their exterminations in secrecy. The United States government is no exception. Additionally, the subject is very complexed and broad. Scholars should consider additional research into the vast array of information and science involved.





#### MITIGATING INFORMATION GOVERNANCE CHALLENGES IN THE GLOBAL ECONOMY

#### DR. HENRIETTA M. OKORO

Associate Professor, Colorado Technical University School of Computer & Information Sciences

#### **ABSTRACT**

Global and local organizations are highly affected by the increasing scenarios of cybercrimes in the COVID pandemic era. The challenges of the information governance programs relate to most enterprises storing complex and sensitive customer data, primarily private or financial, and managing the human workforce with threats of contagious diseases. Hence, the vulnerabilities and threats are the primary targets of cybercriminals to human assets and company proprietary information. The attackers usually make substantial efforts to have the data to utilize it in unleashing their heinous activities successfully. Generally, information governance involves the most effective practices that provide security to the customer data in the different sectors, including financial institutions, higher institutions, manufacturing, and retailers. Thus, to sustain high organizational performance, organizations need effective information governance programs to guide their day-to-day operations to maintain data and information security. This paper aims to identify and evaluate information governance challenges and provide ways to mitigate the challenges and improve the information governance programs in global and local organizations.

#### PROMOTING COLLEGE ACCESS AND SUCCESS

#### DR. CAMACIA SMITH ROSS

#### **ABSTRACT**

Dual Enrollment dates to the 1950s and is one of many programs designed to assist with high school to college persistence. Its' implementation was designed to strengthen America's high schools by supporting stronger pipeline partnerships. High School students who meet specified criteria may dually enroll in post-secondary courses while still in high school and earn up to 36 hours of college credit. Ideally it is beneficial to high school students if schools expand access to rigorous coursework, supported personalized learning, provided students with the chance to build work-based competencies, and allow for innovative approaches to drive student achievement (U.S. Department of Education, 2016).





# UNDERSTANDING PERCEIVED FAIRNESS IN EMINENT DOMAIN: THE CASE OF TEXAS ENERGY PIPELINES

#### DR. JAMES E. LESTER JR. AND ASHRAF ESMAIL

#### **ABSTRACT**

The general problem for this study was that issues of public use of property and resultant seizures or invocation of eminent domain were emotionally charged issues. The specific problem was that it was not known what factors determined the perception of fair compensation in cases of property seizure for utility use, such as natural gas and oil pipelines, and how context might contribute to these perceptions. The purpose of this study was to explore what factors determined the perception of fair compensation in cases of property seizure for utility use, such as natural gas and oil pipelines, and how context might contribute to this perception. Participants included 26 landowners, aged between 35 and 85, in the State of Texas. To address the problem and purpose, the following research question was addressed: Why is compensation perceived as fair or unfair in cases of property seizure for utility use such as natural gas and oil pipelines and how does context contribute to this perception? The findings indicated that the legalistic side of pipeline right-of-way acquisition was fair, while the humanistic side of the compensation offered for right-of-way at the initial first offer was viewed as unfair. Once negotiations reached a point where the next step was condemnation, agreements were reached and considered fair. Future research such as a multiple case study in differing states could be completed to compare and contract results to incorporate a more diverse demographic sample. In addition, to researching figures of compensation to determine better the variances between the parties on the definitions of fairness.

# DO YOU HEAR ME? LIFTING THE VOICES OF UNDOCUMENTED YOUTH THROUGH THE IMPLEMENTATION OF A YOUTH PARTICIPATORY EMPOWERMENT MODEL

#### DR. JANCARLOS (J.C.) WAGNER ROMERO

#### **ABSTRACT**

Youth engagement is critical to a healthy democracy, public life, and to the cultivation of awareness of one's social position. Young people hold a unique place in community citizenry, yet they are often unable to take action or serve in vital community-based leadership roles, thus leading to lower than desired engagement in schooling and community life. Using a Youth Participatory Empowerment Model (YPEM) developed by scholars at a large, Midwest research university, undocumented Latinx youth in New Orleans identified and engaged in a community heritage and social justice need that enhanced their voice and directly affected their participation in school and public life. Rooted in the Social Change Theory of Leadership Development, the YPEM can serve as a catalyst for cultivating the skills necessary to engage in critical social justice dialogue and community action.

#### **ABSTRACT**

Although some research shows that virtual instructions were not as effective for high schooler's, other studies show how now it is important to provide an ongoing virtual school options especially since many had to become leaders of their homes, feel safer at home and like the option of being home for many reasons. The 2020-2021 school year has brought about a sufficient change in how schools educate students and has given high school students' the opportunity to think whether they need to be at school a full day or have options of attending school in person or virtual. As we approach the true technological wave of educating, can the option of attending virtual place them in a better frame of learning or is it necessary to have a teacher physically in front of them with technology, apps, and free resources at hand? Can this be the new form of educating high school students?

#### CONFLICT RESOLUTION STRATEGIES: RECIPES FOR PEACE

#### DR. SHATIQUA MOSBY WILSON

#### **ABSTRACT**

In the aftermath of violence between peacekeepers and the community, this presentation provides edible recipes for making peace and conflict resolution strategies (recipes for behavior) on maintaining peace. This presentation will present the conflict resolution skills taught through literature to the children as well as the final product of a week-long workshop.

CONTINGENCIES AND BOUNDARIES FACED BY FEMALE MANAGERS/SUPERVISOR SEEKING PROMOTIONS IN THEIR AUTOMOTIVE MANUFACTURING UNITS: A NARRATIVE RESEARCH

#### DR. SHERRI HARSHAW & DR. ASHRAF ESMAIL

#### **ABSTRACT**

The problem is the underrepresentation of female managers/supervisors in managerial positions in the manufacturing sections of the automotive industry. Women face numerous contingencies and boundaries because they are women. The purpose of the qualitative personal narrative (PN) inquiry was to advance understanding about the contingencies and boundaries faced by female managers/supervisors seeking promotions in their automotive manufacturing units in the United States. The population was female managers/supervisors in automotive manufacturing plants and related industries located in Alabama, Mississippi, and Delaware. and the sample size was 8 managers/supervisors. The research question addressed: RQ. What are the contingencies and boundaries faced by female managers/supervisors seeking promotions in their automotive





manufacturing units in located in United States? Thematic [inductive] data analysis was used to arrive at the results of six major themes from the data: Theme 1: Contingencies, 2. Boundaries, 2. Workplace Challenges, 4. Knowing your own voice, 5. Letting your voice be heard, 6. Mentorship. The study findings from the PNs of lived experiences of eight female managers/supervisors' who participated in this research study uncovered issues that continue to impair women when they seek advancement opportunities within their automotive manufacturing unit. The researcher recommends future investigation concerning the design of effective, progressive, and driven programs for the future development of women pursuing management-level positions (e.g., mentorship within automotive manufacturing organizations), taking advantage of the expertise of the women leaders who are considered experts in their field facilitating their inclusion in the automotive manufacturing protocol format.

#### RAWLSIAN AND NOZICKIAN APPROACHES TO DISEASE CONTROL AND PREVENTION

#### DR. SYED ADEEL AHMED AND BRANDAN MR. BRENDAN J. MOORE

#### **ABSTRACT**

In this paper, after articulating John Rawls and Robert Nozick's views on justice and their underlying justifications, we suggest that a Rawlsian approach to addressing the coronavirus pandemic better aligns with CDC (Centers for Disease Control and Prevention) guidelines. In doing so, we also suggest that aligning a justice that's most compatible with various codes governed by the AMA (American Medical Association) is the best approach to addressing issues surrounding disease control.

#### **ABSTRACT**

#### DR. SAMUEL ODOM

#### **ABSTRACT**

The academic framework of collegiate education is interdisciplinary and comprised of various college courses that culminate and lead to a two-year degree (Associates), four-year degree (Bachelors), advance degree (Masters) and a professional degree (D.D., J.D., M.D., Ph.D., S.T.D., etc.). The online education community is forging ahead and advancing educational opportunities for fragile communities without students entering the brick & mortar classroom. Students Veterans who served and are serving our nation in Uniform represent and make up a significant percentage of fragile communities seeking academic and educational achievement that translates into job security, economic mobility and sustainable income. For purpose of this research, the interdisciplinary approach to the instructional redesign is aimed at faculty who must change with the times in order to advance opportunities within fragile communities for student veterans at HBCU & UNCF schools. The goal is to better understand barriers to opportunity for Student Veterans in Louisiana's areas of concentrated poverty, referred to as fragile communities by methodically studying the experiences and opinions of those who emerge from and live in them.

#### **ABSTRACT**
